Other provisions and instructions required for filling of Online Applications are given as under:

- Candidates availing the facility of reservation should clearly mention the category applicable. Under any circumstances, change of data will not be allowed after successful submission of Application form. However submitted application form can be viewed and downloaded/printed. On detection, of incorrect/false information or submission of false/fake documents will lead to cancellation of candidature/appointment at any stage.
- Pay Scale** :As per 7<sup>th</sup> Pay commission:- {Pay Matrix Level-10; Rs. 59500 Dearness and other allowances admissible as per rules of UPPCL.

4. Essential Qualification :

For Assistant Engineer(T)(Civil) :

- Candidates should have sufficient knowledge of Hindi written in Devnagri Script.
- A degree in Civil Engineering from a University OR Institution established by law in Uttar Pradesh or from any other Institution recognized by the State Government, or a degree or Diploma recognized as equivalent thereto by the State Government OR
- Section-'A' and 'B' the Associate membership of the Institution of Engineers (India) OR
- Be an Associate member of the institution of Civil Engineers (London).

5. **Age** : Minimum 21 years and maximum 40 years as on 01-01-2020..

Relaxation in upper age limit:

- Apprenticeship training under Apprenticeship Act 1961– Actual period of apprenticeship, subject to maximum 12 months.
- OBC (non-creamy layer) /SC/ ST of Uttar Pradesh domicile -5 years..

- 6 **Reservation** : (I) Reservation will be provided to candidates of Uttar Pradesh domicile only as per rules of UP Govt. and duly adopted by UPPCL. (II) Candidates of States/Union Territories other than Uttar Pradesh should apply as Unreserved Category candidate.

**Note:-** As per calculation based on G.O., there are no vacancies available for "Physically-Handicapped (PH) and Dependent of Freedom Fighter (DFF) candidates under Horizontal Reservation.



7. **No Objection Certificate** : Candidate who are working with any State Govt./Central Govt./Semi-Govt./ Govt. Undertaking organization ,shall have to submit 'NOC' from their present Employer at the time of Joining.
8. **Examination center & Selection Process** : Selection Process will be based on Computer Based Test and Personal Interview. Computer Based Test(CBT) will be held at major cities of Uttar Pradesh .i.e. Allahabad, Varanasi, Agra, Kanpur, Bareilly, Lucknow, Ghaziabad, Meerut, Noida cities etc.. Electricity Service Commission; however have the right to cancel any of the Examination City/ Center and/or add some other cities/centers depending upon the nos. of candidates, administrative feasibility, or any force-majeure conditions etc. Approximately, 75% questions shall be from the Bachelor of Engineering level, 10% questions of General Knowledge/Awareness, 10% questions of Reasoning/aptitude and 5% questions of General Hindi. Each question will carry one (01) mark. Each wrong answer shall carry negative mark of 25%(i.e 0.25 mark). **If the numbers of candidates are more, and the exam is conducted in more than one shift/days, the normalization formula given in Annexure-1 will be used to prepare merit of shortlist/select list.** Candidates, who obtain less than 30 % marks in CBT, will not be eligible for further stage of selection for Interview. Maximum numbers of candidates to be shortlisted for interview will be equal to 2 times the number of category-wise vacancies. Candidates having equal marks as that of last shortlisted candidate will also be called for interview. If a candidate is shortlisted for interview, then appearing in interview is compulsory, failing which his/her candidature will be treated as cancelled. The place and time of Interview will be intimated by ESC separately. The SELECT list shall be prepared on the basis of the combined marks obtained in the CBT and Interview.
- \* CANDIDATE MUST CARRY (i) ADMIT CARD, (ii) PASSPORT SIZE PHOTOGRAPH (SAME AS IN THE APPLICATION FORM) AND (iii) A VALID PHOTO IDENTITY CARD SUCH AS PASSPORT, DRIVING LICENCE, VOTER ID, AADHAR CARD, PAN CARD OR ANY OTHER PHOTO IDENTITY PROOF RECOGNISED BY U.P. GOVT., WHILE REPORTING FOR CBT/INTERVIEW IN ORIGINAL.
  - \* CANDIDATES ARE REQUIRED TO MAINTAIN THEIR UNIQUE E-MAIL ADDRESS AND MOBILE NUMBER TILL FINAL RESULT IS DECLARED.
  - \* IF AT ANY STAGE, IT IS FOUND THAT ANY INFORMATION FURNISHED IN THE ONLINE APPLICATION IS FALSE / INCORRECT OR THE CANDIDATE DOES NOT SATISFY THE ELIGIBILITY CRITERIA FOR THE POST APPLIED, THE CANDIDATURE WILL BE TREATED AS CANCELLED.
  - \* Candidates having undergone apprenticeship training under Apprenticeship Act-1961, will be given age relaxation and preference as per order of Hon'ble Supreme Court, in case, all other requisite parameters being the same.
9. **Syllabus for various disciplines**: The syllabus for Civil Engineering will be same as that of GATE-2020.
10. **Training**: The selected candidate has to undergo a training programme, for a period as decided by UPPCL. On successful completion of the training, the candidate shall be considered for absorption as per existing rules of UPPCL.
11. **Transparency**: For the complete transparency of the held CBT, the Electricity Service Commission shall arrange to display the answer-key for 3 days on the official website of UPPCL or provide a link on their registered E-mail, as far as possible after two days of the examination or provide a portal, from where a candidate can download his answer-sheet. The candidate can lodge their protest online, if any, along with proper proof within the stipulated time. Electricity Service Commission will refer all the objections received online, to subject matter experts, whose decision shall be final and thereafter result will be processed accordingly. After the stipulated time, no further objections will be entertained.



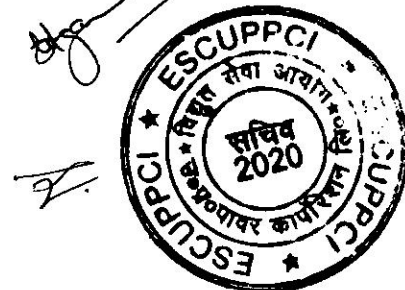

13. **Character:** Candidate will have to produce character certificate issued from the Head of the Institute last attended and also from two responsible / respectable persons who should not be his/her relatives at the time of joining.
14. **Marital Status :** A male candidate who has more than one wife living or a female candidate who has married a man already having a wife shall not be eligible for appointment to the Service.  
Provided that the Chairman may, if satisfied that there are special grounds for doing so, exempt any person from the operation of the provisions of this regulation.
15. **Physical Fitness:** No Person shall be appointed to the Service unless he be in good mental and bodily health and free from any physical defect likely to interfere with the efficient performance of his duties as a member of the Service. Before a candidate is finally approved for appointment he/she shall be required to pass an examination by the Medical Board.

17. **Submission of documents :** All concerned and relevant **original** documents viz Caste certificate( **OBC-NCL candidates must submit their caste certificate issued after 31-03-2020**), domicile certificates (**issued after 31-03-2017**), date of birth certificate, essential Technical qualification certificate/ final marks sheet, Apprentice certificate shall have to be submitted for verification along with a self attested copy of each document on the place, date and time to be decided by ESC. **Failing to produce these qualifying documents in original at the time of checking, will result in conditional rejection of the candidature.**

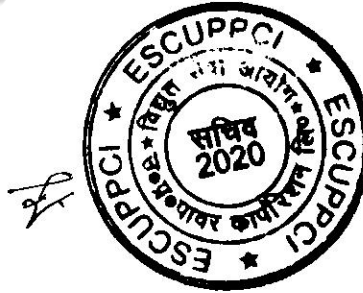

**NORMALIZATION METHOD**Normalized Score for each candidate ( $X_n$ )

Below is the formula that is used in the calculation of the normalized scores of the multisection papers.

$$X_n = \frac{S_2}{S_1} * (X - X_{av}) + Y_{av}$$

<b>S2</b>	Is the Standard Deviation of the shift with the Highest Average Score taken as base for normalization
<b>S1</b>	Standard Deviation for the corresponding shift (to be scaled to S2)
<b>X</b>	Raw score of a candidate
<b>Xav</b>	Simple average of the candidate Shift
<b>Yav</b>	Average corresponding to shift with highest Average (taken as base for normalization)
