candidates for selection test from 13 October 2022 onwards to Join the IAF as an AGNIVEERVAYU. The number and encloyability of female
candidates will be decided as per service requirement.

(THE SELECTION TEST IS NOT FOR SELECTION AS COMMISSIONED OFFICERS/ PILOTS/ NAVIGATORS)

- Application is required to be filled only ONLINE by the candidates and detailed instructions to fill up the same are available

- This examination is valid for AGNIVEERVAYU INTAKE 01/2024.
- ONLINE REGISTRATION shall commence at 1000h on 27 July 2023 and will close at 2300h on 17 August 2023. Only ONLINE REGISTERED applications shall be accepted. For registration log on to https://iagnipathvayu.cdac.in.

Note: - Candidates are advised to register at the earliest opportunity as no extension of registration dates will be accommoded.

5. Age.

Educational Qualification

(a) Science Subjects

Candidates should have passed Intermediate/10+2/ Equivalent examination with Mathematics, Physics and English from Educ Boards recognized by Central, State and UT with minimum 50% marks in aggregate and 50% marks in English.

Passed Three years Diploma Course in Engineering (Mechanical / Electrical / Electronics / Automobile / Computer Science / Instrumentation Technology / Information Technology) from Central, State and UT recognized Polytechnic Institute with 50% marks in aggregate and 50% marks in English in Diploma Course (or in Intermediate/Metriculation, If English is not a subject in Diploma Course).

Passed Two years Vocational Course with non-vocational subject viz. Physics and Mathematics from Education Boards recognized by Central, State and UT with 50% marks in aggregate and 50% marks in English in Vocational Course (or in Intermediate / Matriculation, if English is not a subject in Vocational Course).

(b) Other than Science Subjects

Mandatory Medical Standards. General Medical Standards for AGNIVEERVAYU male & female candidates are as follows:-

- For Male candidates: Minimum acceptable height is 152.5 cms.
- (i) For Female candidates: Minimum acceptable height is 152 cms. For candidates belonging to North East or hilly regions of Uttarakhand, a lower minimum height of 147 cms will be accepted. In case of candidates from Lakshadweep, the minimum height will be

Note: Candidates availing height relaxation for being domicile of North East/Hilly Regions of Uttarakhand/Lakshadweep are to submit domicile certificate with endorsement of domicile status at the time of Phase-II testing. Further, candidates from hilly regions of Uttarakhand must have specific endorsement of hilly region in their domicile certificate.

- Weight: Proportionate to height and age.
- Chest: For Male and Female candidates: The chest wall should be well proportioned with minimum range of expansion of 05 cms.
- Hearing: Candidate should have normal hearing i.e. able to hear forced whisper from a distance of 6 meters by each ear separately.
- Dental: Should have healthy gums, good set of teeth and minimum 14 dental points.

(g) Corneal Surgery (PRK/LASIK) is not acceptable.

Note: Candidates should bring prescription and spectacles for corrected vision, if used. The latest prescription should contain do measurement, Optimalmologist's registration number, stamp, signature and date of prescription should be within a month prior to app for medical examination.

- (h) General Health: Candidate should be of normal anatomy without loss of any appendages. He / She should be free from any active or latent, acute or chronic, medical or surgical disability or communicable disease, infection and skin ailments. Candidate shall be physically and mentally FIT to perform duty in any part of the world, in any climate and terrain.
- (i) Gynaecological Examination (For female candidates): The examination covers external genitalia, hernia orifices and the perineum, any evidence of stress uninary incontinence or genital prolapse outside introllus.

- (ii) Gender (For female candidates): Any candidate if found to have predominant characteristics of the opposite gend vident on external physical examination, will be rejected as Unifit. Any candidate having undergone gender reassignment surger be declared Unifit.
- (i) Pregnancy (For female candidates): Any candidate, if found to be pregnant shall be disqualified and her candidate.

- 10. Body Tattoo. Permanent body tattoos are not permitted, however, tattoos only on inner face of the fore arms (inside of eibow to the wirst), back (dorsal) part of the hand/reverse side of the paim and Tribas with stato which are as per the custom and traditions of their tribes may be considered. TERMS AND CONDITIONS

- 12. Agriveeneyu will be errolled in the indian Air Force under Air Force Act 1950, for a period of FOUR years. Agriveeneyu would form a distinct rank in the indian Air Force, different from any other existing ranks. The Indian Air Force is not obliged to retain Agriveeneys beyond the engagement priority of four years.
- 13. On completion of four years of service, based on organisation's requirements and policies promulgated by the Indian Air Force, Agriveervayu will be offered an opportunity to apply for enrolment in the regular cader of the Indian Air Force as Airmen. These applications will be considered in a centralised manner based on objective critaria, including performance during their four-year engagement period and up to 25% of each specific batch of Agriveervayu will be serolled in regular cader of IAF. Agriveervayu will not have any right to be selected for further enrolment into the Indian Air Force. Selection of the Agriveervayu for further enrolment, if any, shall be at the discretion of the
- Employability. Agriveervayu enrolled under this entry are liable to be assigned any duty in organisational interest at the discretion of the
- <u>Training</u>. On being enrolled, Agniveerveyu will be imparted military training besed on Indian Air Force requirements.
- Leave. Grant of leave will be subject to exigencies of the Indian Air Force. The following leave is applicable for Agriveen/ayu during their
 - (a) Annual Leave. 30 days per year.
 - (b) Sick Leave. Based on medical advice.
- Medical and CSD Facilities. For the duration of their engagement period in the Indian Air Force, Agriveervayu will be entitled for medical facility at Service Hospitals as well as CSD provisions.

- 23. Online Test. Eligible candidates will be sent provisional admit cards for Phase I of testing on their registered e-mail IDs between 48-72 hrs prior to the examination. Candidates are required to download the admit card, take a colour printout and carry the same but examination contre. Name of city & exam date will be intimated to candidates at an earlier date for enable them to plan their movement. Candidates are to bring one blue / black pen and original AADHAAR card along with them for Phase I testing. Details of the test are as follows:

- Marks scored by the candidates in STAR Phase-I Testing will be "Normalised" by using the formula as published on the web site inampatitiveus.cds.cin., to take into account variation in difficulty levels of the question papers across different sessions. Candidates are to bat the explication of Cut-Off for shortsitistic candidates for STAR Phase-II testing and preparation of Final Merit List for selection will be an Normalised Marks' and not on the "Accust Marks' scored by the candidate in STAR Phase-I testing. Further, on normalisation, marks by a candidate in a subject may become less/more than actual marks, and more than total marks of that subject in exceptional cases.

Candidates declared medically unit can avail the option for 'Appeal Medical Board' (AMB) against their unifitness by depositing Rs. 40/i a Government Treasury/RBVSBI strough Electronic Military Receivable Order (e-I/RO) / Military Receivable Order (MRO). The application for Al along with original copy of e-I/RO / MRO, photocopy of Unifiness Certificate are to be submitted to the representative of ASC within three works days of medical examination.

- The recruitment medical officer and the specialist doctors of Armad Forces are the final authorities on declaring a candidate fit or unfit all medical examination, appeal medical board and medical examination prior to enroment.
